Message from Acting President Jeroen Buren

We had a busy calendar in 2016, with CME convening a range of activities, including several regional trips hosting members of parliament and shadow ministers to operations across the state. A highlight for the industry was CME's Women in Resources Awards (WIRA), which attracted more than 1,000 attendees. The issue of gender diversity in the Australian workplace continues to generate discussion and debate across industry, including WA's resources sector.

Now in its eighth year, WIRA provides an opportunity to showcase not only the outstanding achievements of women working in our industry, but also the efforts of women and men who champion gender diversity, and the efforts made by companies to improve the participation of women in our workforce. Message from Chief Executive **Reg Howard-Smith**

The Western Australian (WA) resources sector has continued its transition from a period of construction to production over the last year, and is in good shape. The sector is strong, resilient and well positioned to deliver important opportunities for our communities now and into the future.

From a political perspective, the last 12 months have been particularly busy. The Federal Election in July 2016 saw the return of the Liberal Government with an updated ministry and senate. The recent WA State election in March 2017 resulted in a change of State Government under WA Labor Premier, Mr Mark McGowan. CME looks forward to the leadership of working collaboratively with both governments to ensure the resources sector continues to thrive and benefit all Australians; it is imperative the voice of our industry continues to be heard by key decision makers.

As the peak resources sector representative body in WA, CME continues to represent the views of members and advocate on their behalf.

CME developed the successful iron ore mining tax campaign, as well as developing a broader industry positioning campaign which includes FIFO and subsequently the attraction of living locally; the industry's environmental stewardship and the importance of the gold sector. The iron ore campaign underpinned the importance of the sector to the State and National economy and the employment it provides. It was a message that clearly resonated with its intended audience.

The overarching objective for all campaigns has been and will continue to be to promote the importance of the resources sector and the extent of its contributions to WA communities. The FIFO element of the campaign launched in March. 'Giving Families Choice' is a positive campaign highlighting FIFO as one of a range of choices available to resources sector workers and their families. The new advertisement was shown in regional cinemas and will be followed by a campaign highlighting the choice to live and work residentially in regional communities.

The forthcoming environment campaign will focus on the sector's world leading environmental laws and industry practices. The Gold campaign will recount the history of WA's gold legacy, whilst promoting its contemporary role and export appeal.

In the face of the ever evolving political landscape, CME continues to work closely with members and key stakeholders across government and industry to ensure issues affecting the industry are understood.

CME looks forward to another busy year and is confident the sector will continue to thrive and contribute both socially and economically throughout Western Australia.

People and Communities

Safety

Fibrous Minerals Safety Bulletin: the withdrawal of Mines Safety Bulletin No. 131 by the DMP on the management of fibrous minerals on mining operations and the involvement of industry in the discussion of next steps to consider this matter.

Employment (skills and diversity)

Women in STEM: the Department of Local Government and Communities developing and promoting 10 actions to support women in science, technology, engineering and maths (STEM) and trades.

Verification of Competency (VOC) Framework: industry collaboration to improve and streamline verification of competence for high risk work across the resources sector. The collaborative effort has resulted in the establishment of agreed assessment standards for scaffolding with implementation of the framework continuing throughout 2017.

High Risk Work Audit: the Training and Accreditation Council (TAC) recommending immediate action to address issues of non-compliance in Registered Training Organisations who deliver high risk work training.

Community

Industry Positioning: CME is developing an industry positioning, campaign, which includes FIFO as well as the attraction of living locally. The aim is for increased awareness by government, political and community stakeholders regarding the choices made by employees of the resource sector who choose to do FIFO or live regionally dependent on how it suits their lifestyle and family situation.

Mental Health and FIFO Inquiry: CME being appointed Chair of the Mining Industry Advisory Committee Mental Health Strategies Working Group which is charged with implementing the Inquiry recommendations, including sharing industry best practice in mental health strategies in the workplace. Sharing best practice has increased recognition by government and community stakeholders of the resources sector's proactive approach to wellbeing in the workplace.

Mental Health Commission Mental Health Research Steering Group: securing industry appointments to the Mental Health Research Steering Group to ensure robust research is undertaken which will support ongoing efforts to address mental health issues in the workplace.

Economic Impact Study: improved awareness of the direct economic impact the resources sector has on the Western Australian economy through greater media coverage of CME's Economic Impact Study.

Economic Competitiveness

Regulation

Review of EPA's Policy Framework: the Environmental Protection Authority (EPA) adopting a more simplified policy framework, arranged in a hierarchical manner which clearly links back to statutory functions and powers.

Department of Environment Regulation Part V Reform: new guidance documents and environmental standards relevant to the resources sector adopting a risk-based approach to licensing and regulatory duplication minimised.

Mining Proposal Guidelines: revised DMP guidelines which adopt a risk-based approach, provide greater flexibility and reduce the approval burden over the life of a mine.

Department of Mines and Petroleum (DMP) Mines Safety Branch (MSB) Independent Review: the review report prepared by Deloitte incorporating recommendations made by CME on the need to establish a set of regulatory priorities to support transparency and build industry's trust in the effectiveness of the regulator. DMP has supported the majority of review recommendations and will progress them in consultation with industry.

Ventilation Code of Practice: amendments to the draft Code of Practice to address ambiguity and provide clarity to where the guidelines sit within the proposed new legislative framework.

Taxation and royalties

Mid West Ports Port Enhancement Project (PEP): the Port's remaining PEP debt being repaid in full by the State Government with the \$2.56/tonne PEP charge removed from 1 July, 2016.

State Budget: recommendations regarding the ongoing funding for the Exploration Incentive Scheme and the Western Australian Biodiversity Science Institute being adopted.

Local Government Rates: the reduction of a number of local government rates following objections tendered by CME to proposed increases where justification for the increases could not be provided.

Mines Safety Levy: agreement from DMP to restructure the levy reporting methodology, in consultation with industry, to significantly reduce administrative burden of calculating levy payments.

Infrastructure

State Planning Policy: amendment to the drafting of State Planning Policy 2.5 to address the need to recognise the inter-relationship between the policy and other health and environmental policies.

Natural Resources

Environment

Pilbara Environmental Offsets Fund: key industry requirements in relation to the governance, investment framework and reporting requirements of the non-statutory government administered fund for Pilbara offsets being adopted.

Land Access

Native Title Registration of Indigenous Land Use Agreements (ILUAs): immediate amendments of the Native Title Act 1993 to address uncertainty surrounding the registration of ILUAs created in the McGlade case.

Aboriginal Heritage: the exclusion of a statutory consultation right into the Aboriginal Heritage Amendment Bill. This would have led to litigation as its meaning was tested and generally a retrograde step outweighing any potential benefits of the Amendment Bill.

Rangelands Reform: the proposed rangeland leases not unduly prejudicing mining, petroleum and State Agreement interests.

Exploration

Exploration Incentive Scheme: funding for an additional \$30 million over three years from 2017-18 through the Royalties for Regions initiative. This investment is crucial to ensuring the future viability of the resources sector in Western Australia.
