The next review is due in June 2019 and is already underway. COSH Legislative Advisory Committee Meeting

CME attended the first 2019 meeting of the Commission for Occupational Health and Safety (COSH) Legislative Advisory Committee (LAC) last week.

The COSH LAC is reviewing the draft Consultation Documents for the proposed content of the Work Health and Safety (WHS) Regulations. This will include regulations to cover general industry as well as the mining, petroleum and pipeline sectors.

LAC recommendations will be submitted to COSH for approval and subsequently the Consolidation Documents will be released for a period of public consultation. LAC will meet on a bi-weekly basis through February and March and CME will reconvene its WHS Legislation Working Group during this time to discuss its position.

Mental Health Industry Forum – 18 February

On 18 February, CME is holding a Mental Health Industry Forum with members to continue to progress industry's response to recommendations from Curtin's research project into FIFO Mental Health.

In December 2018, CME announced this response would include a partnership with Lifeline to consolidate and make accessible a suite of industry specific tools to support organisations as they continue to improve on site mental health strategies taking into account these most recent research findings. This package will build on the CME Mental Health Blueprint developed in 2015.

PwC Common Skills Working Group

The Resources and Infrastructure Industry Training Package is currently being revised to ensure learners are best equipped with the skills needed for the future of work. The review is being managed by Skills For Australia (PwC).

CME is a member of the Common Skills Project Working Group (PWG) as part of the RII review and attended the second PWG meeting to discuss the progress of the project on 23 January. The project is currently in the consultation phase, with PwC seeking views from various stakeholders on proposed changes to units of competency, various entry level qualifications in the package and the potential creation of skill sets for ventilation roles.

DMIRS Petroleum Regulations Industry Meeting

Reforms on work health and safety (WHS) legislation in WA are continuing to progress, with the government now focusing on developing sector specific regulations that will support the WHS Act.

On 23 January, the Department of Mines, Industry Regulation and Safety (DMIRS) hosted an industry meeting on the proposed content WHS (Petroleum) Regulations.

A number of industry representatives attended to provide feedback on what is known about the proposed changes. Public consultation on more detailed content relating to the changes is likely to commence during the first half of 2019.

Australian Carbon Credit Unit Market Update

The Clean Energy Regulator (CER) has released its inaugural Australian Carbon Credit Units (ACCU) Market Update to provide its view of supply and demand of ACCUs under current policies, and key factors that may influence the market in the near future. This update is intended to increase market transparency to assist responsible emitters such as those in the resources sector who may need to source and surrender ACCUs under the Commonwealth Government's safeguard mechanism.

Updates to the Index of Biodiversity Surveys for Assessments

The Index of Biodiversity Surveys for Assessments (IBSA) is the Department of Water and Environmental Regulation's online portal to information about land-based biodiversity surveys in Western Australia.

The IBS currently has 241 biodiversity surveys registered in the IBSA Portal.

The Department has recently made the following announcements:

- Minor updates have been made to the IBSA Instructions document and IBSA Metadata and Licensing Statement. New IBSA data package submissions should reflect the updated Instructions and use the updated Statement template.
- The IBSA instructions page now hosts a downloadable example of an IBSA Data Package and demonstrates how it should be presented.
- A recording of the IBSA stakeholder familiarisation session from last year has been published online, for those who were unable to attend.

Cockburn Sound and Pilbara Industry Forums for CRC for Coastal Health & Wealth

The University of Western Australia (UWA) is coordinating a bid for a Cooperative Research Centre (CRC) for Coastal Health & Wealth (CH&W). The CRC CH&W seeks to secure long-term growth in productivity, profitability and the health of Australia's coastal industries and ecosystems, including growing the global competitiveness of assets (natural and built), industries and agribusiness (e.g. minerals, manufacturing and technology, seafood production) in Australia's coastal areas and communities.

CRCs are established through the Australian Government grant program which offer up to 1:1 matched investment funding over a 10 year period, with grants decided through a competitive bid process.

To assist with the bid process, UWA will be hosting Industry Forums for the different case studies locations to be investigated through the CRC. The first Industry Forum will focus on Cockburn Sound and will be held tomorrow on Thursday, 31 January, 9.30am to 1:30pm at UWA.
