#### Building and Construction Industry Training Fund – Five Yearly Review

#### **Workplace Exposure Standards**

CME is seeking member feedback on proposed changes to workplace exposure standards for respirable crystalline silica, which is currently <u>available</u> for stakeholder review and comment. The changes are being proposed by Safe Work Australia (SWA) who is currently evaluating the <u>Workplace exposure standards for airborne</u> <u>contaminants</u> to ensure they are based on the highest quality evidence and supported by a rigorous scientific approach.

CME is seeking member feedback by 8 April to inform an industry response on the matter.

#### **Legislative Advisory Committee**

CME attended the third meeting of the Commission for Occupational Health and Safety's (COSH) Legislative Advisory Committee (LAC). Prior to the meeting, CME reconvened its Work Health and Safety (WHS) Legislation Working Group to discuss industries' positions on related matters. The COSH LAC is reviewing the draft Consultation Documents for the proposed content of the WHS Regulations. This will include regulations to cover general industry as well as the mining, petroleum and pipeline sectors.

LAC recommendations will be submitted to COSH for approval, and the consolidation documents will be released for a period of public consultation in the coming months. Contact CME to take part in this process.

CME's new Director Policy and Advocacy, Rob Carruthers, appeared as part of an industry panel at the MCA Biennial Tax Conference last week. A key focus of the Conference was Australia's increasingly uncompetitive company tax rate and its negative impact on investment attractiveness.

The panel discussed factors affecting Western Australia's competitiveness. Rob said that while the State's economy has moved positively beyond green shoots, driven by strong growth in investment and employment in the resource sector, WA cannot simply rely on its natural advantages in a globally competitive market. The panel was unanimous in agreeing the importance of stable and progressive government policy, and also the efficiency of regulatory processes, as key drivers of investment confidence.
