



### **Annual Economic Contribution Survey – Last Call**

CME has received 39 survey responses (32 completed and 7 partially completed) from ordinary members for our annual Economic Contribution Survey. We will be following up outstanding responses in February in order to prepare and launch the 2018-19 Economic Contribution Factsheets ahead of the 2020-21 State Budget.

Providing data to this survey is critical for demonstrating the sector's collective contributions to employment, businesses, local governments, communities and the wider Western Australia economy. CME aggregates the received data into legislative assembly electoral districts and regions, which will be crucial in the lead up to the 2021 State Election.

**Aboriginal Cultural Heritage Act 2020 Workshop**

The State Government is currently drafting an exposure draft bill to repeal and replace the *Aboriginal Heritage Act 1972*. To inform this drafting process, CME coordinated a member workshop to enable the Department of Planning, Lands and Heritage (DPLH) to provide an interim update on the proposed Bill requirements including the Aboriginal heritage impact categories, assessment process and approval pathways. Following the briefing, members discussed with DPLH representatives key considerations in the context of exploration, project development and mining and the linkages with grant of tenure and the Native Title system.

CME is preparing a submission based on member feedback from the workshop on the impact categories, assessment process and approval pathways for DPLH consideration. DPLH will be publishing an Exposure Draft Bill (Green Bill) for public consultation as the next phase of their consultation process. The new Act is expected to be called the *Aboriginal Cultural Heritage Act 2020*, with introduction of the Bill into Parliament anticipated in mid-2020.

# **Productivity Commission Inquiry into Mental Health – Draft Report**

In late 2019, the Productivity Commission released a comprehensive <u>draft report</u> of its inquiry into mental health. CME welcomes the release and acknowledges the work of the Commission in reviewing all 560 submissions, including CME's. CME was pleased to see acknowledgement in the report of our key recommendations regarding a holistic and coordinated approach to mental health services and information to be provided by government, whilst recognising employers have a role to play.

The report recommends employers treat mental health hazards as they would any other OSH hazard in their workplace, and to select risk-based approaches to prevent

and manage mental health issues for their employees.

CME will continue to support the proactive work already being undertaken by our members in the mental health space and is currently drafting a response to the draft report. Further feedback from members is welcomed.

# Safe Work Australia – Review of Workplace Exposure Standards

Safe Work Australia (SWA) is currently evaluating more than 700 existing Workplace Exposure Standards (WES) as part of a large project. SWA has been releasing the draft proposed WES in batches for public comment, with the latest release on 17 January including a proposal for Diesel Engine Emissions and Hydrogen Cyanide, amongst other products. SWA has chosen to defer giving a recommendation for Diesel Engine Emissions at this time, but the proposed WES for Hydrogen Cyanide does represent a substantial reduction and CME anticipates that this will be of relevance to our members in the gold sector.

CME is currently working with members to collate feedback on the draft proposed WES reports to ensure they are based on the highest quality evidence and supported by a rigorous scientific approach which can also be implemented in practice.

The Department of Environment and Energy (DoEE) have extended the due date for submissions on the Discussion Paper for the *Environmental Protection and Biodiversity Conservation Act 1999* (EPBC Act) statutory review. Submissions are now due to DoEE by 17 April 2020.

CME will be hosting an Approvals Working Group on 6 February to discuss the Discussion Paper and EPBC Act more generally.

CME will be making a submission and welcomes member feedback by 7 February to assist with preparation of a submission.

## WHS Legislation Working Group

On 23 January, CME's WHS Legislation Working Group convened to discuss the WHS Bill, tabled in Parliament on 27 November 2019.

Representatives from the Department of Mines, Industry Regulation and Safety and the Mines and Petroleum Minister's office attended to brief members on several key areas of the Bill. Members also discussed next steps in progress of the Bill through Parliament, expected to take approximately six months.

### South West OSH Forum

CME facilitated the final South West OSH Forum for 2019 in Bunbury in December. The forum was well attended by members, who received a presentation from Paul Foley from the Department of Mines, Industry Regulation and Safety (DMIRS) on the progress of implementation of site Health and Hygiene Management Plans.

Graham James from DMIRS also gave an overview of some recent improvements to the business intelligence model within SRS, which will enable greater analysis of WHS information and data-driven planning by members. In addition to round-table discussions sharing best practice and learning from each other, members also received updates on key CME policy areas including the proactive Lifeline mental health partnership, WHS Legislative reforms, and the Safe Work Australia Workplace Exposure Standards Review.

### Mental Health Working Group

On 21 January 2020, the Mental Health Working Group met at CME's office. BHP shared a case study regarding a well-received mental health initiative, and WIRA finalist Dr Ali Burston attended to present to members about the development of policies to meet the requirements of the Mental Health Code of Practice, as well as an update on an industry mental health literacy project.

Members agreed on the proposed output of Phase 1 of the Lifeline Partnership, which covered the co-design of a range of mental health tools for the resource industry, and an overview of Phase 2: Prototype and Test was given. Members discussed the proposed recommendations in the draft report from the Productivity Commission's Inquiry into Mental Health and gave feedback on CME's draft submission.
