Message from the CEO

April has been another busy month, with the start of the Federal Election campaign. Western Australia and Victoria look like being the two jurisdictions where the election will be won and lost. The economy, climate change, urban infrastructure and health appear to the salient issues.

CME's Executive Council met and endorsed the three strategic priorities for the

organisation: Competitiveness, Capability & Contribution. Over the next few months, CME will be aligning our structure, personnel and objectives to align with these three priorities.

WA Premier Mark McGowan recently attended a CME Management Committee meeting. Issues discussed included the continuing need for WA to remain globally competitive; the preference for an emissions reduction scheme to be nationally managed and implemented; and the demand for skills in our industry.

I attended a meeting of resources sector advocacy organisations in Sydney recently with the Queensland Resources Council, Minerals Council of Australia and NSW Minerals Council. All organisations face similar issues and there was consensus among attendees to work together to better represent our members and reduce duplication.

In my many meetings with member companies over the past month, there is a strong sense of anticipation and growing optimism within the sector. I expect that this will likely start to appear more public in late 2019.



Work Health and Safety Regulations - Draft Consultation Package Endorsed

At the April Commission for Occupational Safety and Health (COSH) meeting, the final draft consultation package for the proposed Work Health and Safety (WHS) Regulations was endorsed for submission to Minister for Mines and Petroleum, the Hon. Bill Johnston MLA. The endorsement relates to the presentation of materials within the consultation package and not the contents of the regulations themselves.

In agreeing to the package, CME requested the Government's final position on the proposed content for the WHS Bill be clarified ahead of the commencement of consultation on the regulations. It is expected consultation will commence in May and run for three months. CME is represented on COSH and the COSH Legislative Advisory Committee and will be making a detailed submission as part of the upcoming consultation process. CME attended the Regional Migration Conference in Adelaide in March. The Goldfields had a Designated Area Migration Agreement (DAMA) approved in March, and discussed with other regions its implementation. DAMAs are intended to provide flexibility for states, territories or regions to respond to their unique economic and labour market conditions through an agreement-based framework. Under the DAMA framework, employers in designated areas experiencing skills and labour shortages can sponsor skilled and semi-skilled overseas workers.

Delegates heard from the Northern Territory and Regional Development Australia Barwon South, who recently had a DAMA approved in December 2018, about the implementation and roll out of their designated agreements in their respective regions.

The re-formed Mining Industry Advisory Committee (MIAC) mental health strategies working group held its inaugural meeting on 18 April 2019. The Department of Mines Industry Regulations and Safety (DMIRS) will Chair and provide secretarial support for the re-formed group and membership has been streamlined to include equal tripartite representation as agreed by MIAC.

At the meeting, members reviewed and approved the revised Terms of Reference and discussed the future role of the working group, including ongoing consideration of recommendations from the FIFO Mental Health Inquiry Final Report which were referred to MIAC. The group will also play a key role in reviewing the proposed tools to support the implementation of the FIFO Mental Health Code of Practice including the DMIRS Audit Tool.

Safe Work Australia Workplace Exposure Standards Submission

CME is finalising a submission to Safe Work Australia (SWA) on the proposed workplace exposure standard (WES) for Respirable Dust Crystalline Silica (RCS). WES are levels of airborne concentrations of a particular chemical or substance in the workers' breathing zone that should not cause adverse health effects or undue discomfort to nearly all workers. Under model work health and safety (WHS) law, WES's are legal concentration limits that must be adhered to.

The current WES set by SWA for RCS is an eight hour time weighted average (TWA) of 0.1mg/m3. As part of the ongoing WES review, SWA is proposing to reduce the WES for RCS to 0.02mg/m3. CME is concerned the proposal is unnecessarily conservative and has not taken into account the best available evidence or the practicality or feasibility of implementing such a change.

CME will be lodging the submission for the 30 April deadline and thanks all those members who have reviewed and provided input.



The fund also provides funding to develop business cases and undertake feasibility, scoping or planning studies.
