EPA Consultation on Greenhouse Gas Emissions

The Environmental Protection Authority (EPA) has commenced consultation on its

greenhouse gas emissions guidance through the release of a [Background Paper](#).

In particular, the EPA is seeking views on:

1. The information that should be required by the EPA for Environmental Impact Assessment

- Information on greenhouse gas emissions and their mitigation which the EPA should expect and consider in making any advice on a proposal
- Information the EPA should expect on how a proposal aligns with Australia's emissions reduction targets
- The need for, and any reasonable constraints on, transparency in emissions data and proposed mitigations

2. How emissions associated with a proposal should be considered by the EPA

- The scope of emissions to be considered
- The relevance and context for considering indirect scope 3 emissions
- The relationship to national or state emissions targets and regulation
- Consistency with the EPA's duty to use its best endeavours to protect the environment

3. The constraints on potential emissions mitigation conditions the EPA should recognise

- The appropriateness and practicability of measures to mitigate greenhouse gas emissions, including nature and level of planned reductions or offsets
- The timing of planned reductions or offsets
- The kinds or size of proposals to which the guidelines should apply

4. Any other advice related to the assessment of greenhouse gas emissions by the EPA that would further clarify or improve the guidelines.

CME, through the CERG, will be making a submission on this consultation. The next CERG meeting will be held on the 15 July with submissions due by 2 September 2019.

CME's North West Manager, Anthony Miller recently joined WA Education Minister, the Hon. Sue Ellery MLC to announce a new initiative for Karratha Senior High School students to undertake pre-apprenticeship courses from next year.

A total of 24 year 11 students will obtain a Certificate II Pre-Apprenticeship qualification in Electro Technology Electrician or Engineering Mechanical Trade at North Regional TAFE as part of the Pilbara Collaboration, an initiative coordinated by CME.

Collaboration partners BHP, Chevron Australia, CITIC Pacific Mining, Fortescue Metals

Group, Rio Tinto Ore, Roy Hill, Woodside and Yara Pilbara have all committed to ensuring a job interview for available apprenticeships to students who apply and who have completed a relevant pre-apprenticeship course with North Regional TAFE.

The Pilbara Collaboration was developed in response to Premier Mark McGowan's request for industry and Government to work together to build on individual companies' existing social and economic contribution to the Pilbara region. The first agreed priority area for collaboration has been employment, education and training.

CME Submission on Phase Two Reform of Aboriginal Heritage Act 1972

CME continues to contribute to consultation on the repeal and replacement of the Aboriginal Heritage Act 1972 with a submission to Phase Two of the formal consultation process. CME's submission on the Phase Two proposals for new legislation has been developed in conjunction with the Native Title and Aboriginal Heritage Working Group, and addresses key elements within the proposals for new legislation. Notably, a tiered fit-for-purpose assessment model as suggested by CME in its Phase One submission has been proposed by the Department. Recommendations made as part of the Phase Two submission remain focused on ensuring practical legislation which delivers efficient and equitable decision making on land use in Western Australia. While several proposals require further consultation to deliver on the desired outcomes, CME hopes that recommendations provided within this submission assist the Department in developing draft legislation.

The event was co-chaired by Linda Dawson (Rio Tinto) and Kevin Smith (National Native Title Council).

The workshop sought to build the foundations for a new community of practice – an inclusive, practical-focused network to share, learn and advance practice focused on implementation of minerals-related Indigenous agreements and partnerships by:

- Building awareness of how different stakeholders may view success, and working together to develop a shared high-level vision of successful implementation of minerals-related agreements and partnerships
- Identifying and prioritising practical and collaborative actions to support enhanced outcomes from implementation of minerals-related agreements and partnerships.

The community of practice will be open to representatives from a range of Traditional Owners and Aboriginal and Torres Strait Islander communities and organisations from major mining regions and representatives from the minerals industry, government and academia.

The workshop, Community of Practice and subsequent actions will be discussed

through CME's Native Title and Aboriginal Heritage Working Group.
